- To help students at the participating schools (grade 2, 3, 4 and 5) to acquire a large English oral vocabulary in a relatively short time and to provide a solid basis for the successful reading of textbooks and other literature.
- To help students to achieve a demonstrably high literacy level at the end of primary school and notably higher scores on the national grade 7 literacy tests.
- To train the teachers to enhance their professionalism, expand their didactic repertoire and their knowledge on language acquisition, and to improve their oral proficiency of English.
- To provide the teachers and schools with word maps, posters and teacher cards plus periodic assessment papers and other related teaching aids and teaching materials.
- To set up a local structure to support and to train the teachers.
- To supply a teacher training curriculum for the teachers in primary education concerning the development of school-language and to certificate the outcome of these teacher trainings.

- To supply a 'train the trainer' program for the teacher trainings.
- To build on a solid basis, sustainable cooperation in the region with other ngo's the district and provincial representatives of the Ministry of General Education Zambia, the teacher training college in Chipata and others.
- To promote and carry out scientific research and surveys within the field of primary and secondary education and concerning outcomes of the project.
- To provide assistance in improvement of educational activities in Zambia.


